- Proof of own consent (if applicable)
- Letter from the accountant confirming that the company/ close corporation complies with all statutory requirements
- Proof that financial systems acceptable to Gauteng Enterprise Propeller is in operation for the submission of monthly financial statements
- Resolution authorizing the company/close corporation to enter into a contract finance agreement with Gauteng Enterprise Propeller
